

 - a. The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (Format attached).
 - b. Those UG/PG qualifications that are not yet recognized by the Central Govt. It is mandatory for the college to apply to the Central Council through Central Govt. and ensure that Permitted/Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.

Important Note:

- 1) The Continuation / Extension of Affiliation is issued for the Academic Year 2022-2023 subject to the permission of National Commission for Homoeopathy/Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1st year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- The admission shall be done only through the Competent Authorities.

Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, as per NCH Act 2020 and its relevant regulations. As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforms were examined by the Medical Assessment and Rating Board.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls

1. Teaching faculty:

The college has submitted 12 guest faculties, but 02 guest faculties only are found to be eligible.

Discrepancies found in guest faculty are below:-

- a. Dr. Hitesh Padamshi Fariya, Dr. Shruti Thakkar, Dr. Leena Sanjay Bagadia, Dr. Salil S. Bendre, Dr. Ksitioj Manoj Shah, Dr. Saurabh Satish kumar Sanjanwala, Dr. Janak Mahendra Shah, Dr. Falguni Saurabh Sanjanwala, Dr. Archna Abhang Prabhu, Dr. Nishit Champat Jain-They are not found eligible as have not submitted previous experience of teaching.
- 2. Miscellaneous:-
- i. Attendance and acquittance of 19 teaching staff not provided.
- Attendance of 04 non-teaching staff not provided.
- Attendance of 19 hospital staff and acquittance of 18 hospital staff not provided.
- Form -16 of 08 hospital staff and 07 non teaching staff are not from traces portal.
- v. ESI clarification is submitted by college for teaching, non- teaching faculty and hospital staff that none of our full time teachers, non- teaching staff and hospital staff has salary below the limit of coverage mentioned under the ESI act 1948.
- After considering the provisions of NCH Act, 2020 and its relevant regulations permission of the Medical Assessment and Rating Board is issued to Smt. Chandaben Mohanbhai Patel Homoeopathic Medical College and Hospital, Natakkar R.G. Gadkari Marg Irla, Vile Parle (W), Maharashtra, Mumbai-400056, with intake capacity of 100 seats for BHMS Course for the academic year 2022-2023.
- 4. All admissions in Under Graduate/Post Graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that

P.F. Damana 22/10/22 State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under.

- 5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.
- 6. The college has to comply with the full requirements as per NCH Act, 2020 for conducting the course. All deficiencies observed, has to be rectified within 30 days' time from issue of this permission letter. Compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance.
